





CREATE A JEWISH

On January 9th, fourteen area synagogues and agencies began their journey to discover the benefits of legacy giving as participants of Create A Jewish Legacy Cohort II. Through Create a Jewish Legacy, our synagogues and agencies gain an

in-depth understanding of the planned giving process so that they can strengthen the financial outlook of their organizations from within.

The Federation, together with The United Jewish Endowment Fund, creates strong partnerships with agencies and synagogues as a community leader, convener and catalyzer so that we can plan strategically and effectively with a strong, collective voice. Create A Jewish Legacy is a prime example of how successful partnerships strengthen our community and ensure stability for years to come.

Recognizing that committees change over time and that leadership rotates in and out of positions, the seventeen agencies who participate with Cohort I have been invited to have their new committee members sit in on training sessions with Cohort II. This continuing education will ensure successful leadership training and sustainability of CJL at each organization. Fee Structure Update

Beginning in July, UJEF made a slight modification to its fee structure for standard funds* to make fees more consistent across fund types and to create a minimum fee that covers the costs of administering funds effectively. Most funds will not be affected by the new structure. Because the annual minimum fee is now \$250, funds with balances under \$25,000 are most affected by the new minimum.

Annual fees will continue to be calculated based on the average daily balance in each fund.

Minimum fee per year	\$250
Fee on the first \$500,000	1%
Fee on the next \$9.5 million	0.50%
Fee on all assets over \$10 million	negotiable

*This fee structure applies to all funds and gifts with the exception of local partner agency/ synagogue funds and gift structures or assets that require additional administration, such as trusts or real property. Family fund discounts remain unchanged.

While the minimum to open a fund remains \$10,000, there is no minimum balance requirement.
