Key Donor Life Insurance Leverages the Impact of Your Gift

You can have a lasting effect on the Jewish community by creating an endowment fund with a life insurance gift through our Key Donor Life Insurance Program. This program is available for qualifying life insurance policies where UJEF is owner and beneficiary of a policy with a face value of at least \$120,000.

You and the Endowment Fund secure a policy illustration from a qualified life insurance company for a four-pay universal or whole-life policy.* The Endowment Fund shares the cost of the new policy with you. Your gifts to the Endowment Fund to cover premiums can be tax-deductible charitable donations. Once the proceeds of the insurance policy are distributed, UJEF will establish a permanent fund in your name or in the name of a loved one. Each year, UJEF will distribute from the fund

The Legacy Society recognizes those individuals who have committed or donated at least \$10,000 to create or increase a permanent fund to sustain the vitality of our Jewish Community.

In addition to the Key Donor Life Insurance program, you can transfer ownership of an existing life insurance policy to the Endowment Fund and name the Endowment Fund as the beneficiary—which may allow you to receive a charitable tax deduction—or add the Endowment Fund as a beneficiary of the policy. Best, AA or above by Standard & Poor's and AA2 or above Moody's; and (2) illustrating proposals must show a maximum of a four-year premium payment period, using projections at 1% below the company's current interest/dividend rate. Apple Cake Recipe

What You'll Need

3 eggs
3/4 cup sugar
1/3 cup oil
3/4 cup cake meal
5 apples, peeled & sliced (Granny Smith)
Topping:
1/3 cup chopped walnuts
1/2 cup sugar
2 tsp. cinnamon

How to Make

Preheat the oven to 350 degrees. In a medium sized mixing bowl, beat the eggs with the sugar and oil until the mixture is light. Add the cake meal and mix well. Pour half of the mixture into a lightly greased 8 or 9 inch square baking pan. Distribute half the apples over the batter. Pour the remaining batter over the apples and cover with the remaining apples. Topping: Combine topping ingredients in a small bowl; sprinkle over the apples. Bake in a preheated 350 degree oven for approximately 1 1/2 hours. Serves 8-9. You can double the recipe & bake in a 9x13 pan.

Jewish Food Experience

What do an interfaith couple in Leesburg, a young Jewish professional on U Street and an Orthodox family in Silver Spring have in common? Each has personal connections to Jewish food, culture and tradition—whether it's an age-old family challah recipe, a vegan Passover Seder meal, or bagels and lox on Sunday morning.

Cooking, eating and talking about food are not just delicious pastimes in Jewish life. Jewish food has such special meaning in Judaism that it is intrinsic to the Jewish experience past, present and future. To Jews around the world, food represents history, culture, faith, cherished personal memories and family ties now and to generations past and future, as well as a crucial way to help those in need.

The Jewish Food Experience (JFE) is an exciting new initiative that will provide opportunities for Jews across backgrounds, generations and denominations to engage in Jewish life, community, identity and social action through the universal touchstone: food.

This innovative project will offer easy accessibility for all to participate in dialogue, personal action and information sharing. The JFE is also designed to promote the work of the United Jewish Endowment Fund (UJEF) and The Jewish Federation of Greater Washington through this common interest of Jewish people.

At the core of the JFE will be a robust website that will include everything from regularly changing columns and blogs by leading chefs, cookbook authors and celebrities to holiday celebrations, special events, restaurant and cookbook news, discussion communities and more. Visitors will be able to build personal recipe boxes and share postings, pictures and videos about their own Jewish food experiences as well as access opportunities for

social action and ongoing listings of events related to Jewish food throughout Greater Washington.

In addition, the JFE will both produce top-quality programs and events in the metropolitan area and work with Federation partner agencies, congregations and other local Jewish and food organizations and businesses. Plans already include culinary competitions, embassy programs, family cooking classes, food and wine tastings, photo contests such as "Take Your Bubbie to Brunch" and a Jewish food festival in 2013.

As work on this project moves toward launching the website in December and events in 2013, we are looking for food writers, bloggers, photographers, chefs, caterers, restaurateurs, wine merchants, food-related non-profits and other partners who might be able to provide expertise and content for the site. Making a Cinderella Story Come True: Empowering Women in the Negev

"It has been a while since I worked and when I worked I always felt exploited. Now in Cinderella I feel that they are taking care of my conditions and benefits and I can't wait for the enrichment course to begin. I'm sure that in one year I will be managing an office. This is a dream that will come true. I'm sure about that."

For 15 years, Eden, a nonprofit organization, has worked to promote educational and social advancement in the northern Negev, located in the lower part of Israel. Eden's programs strengthen

the lives of Israelis living in the Negev. Cinderella, one of Eden's programs, is a project designed to help provide unique educational frameworks to needy sections of the population to help them fulfill their potential. Cinderella is an employment and educational opportunity for women who are being oppressed.

All over Israel, many women are exploited socioeconomically and have weak employment prospects due to lack of mobility, education, language and more. These women are underpaid, receive no health benefits and have minimal insurance coverage.

Eden is the organization that manages Cinderella

Because of their weakened situation, these women are limited in their ability to stand up for their basic rights.

Cinderella empowers these women. As a domestic help service company, Cinderella provides safe transportation, pays a fair wage and provides social benefits and insurance to its employees.

Cinderella employees work four days a week, and on the fifth day they learn a profession in training programs and courses offered by the Ministry of Industry, Trade & Labor.

In partnership with The Morningstar Foundation, the UJEF will be investing with the Israel Venture Network (IVN), which has identified this project for support. IVN is comprised of business professionals in Israel who want to leverage their business knowledge with local and international funding to assist fledgling non-governmental organizations so they can thrive in Israel. This year, both UJEF and The Morningstar Foundation have committed \$33,500 to this project, with the balance of funding and mentorship support being provided by IVN. IVN will work with Cinderella, as it has with other social venture programs in Israel, to

strengthen its infrastructure and increase its ability to be successful. They will develop a strategic model that can be replicated, spreading the impact of the venture throughout the country.

The United Jewish Endowment Fund is pleased to help bring this program to fruition. It fits squarely within the UJEF's new grant
