## The Power of Twenty Shekels

On July 11th, 2012, twenty shekels changed the world for two people—Sasha and me.

This summer, I visited a Jewish Agency for Israel summer camp that was 45 minutes outside of Odessa in the Ukrain e. As I walked off the bus with 100 other Jewish Federation colleagues and leaders from around North America, I noticed Sasha, a 16 year old boy, who was leading the group in a well known Israeli line dance.

During dinner I spoke with Sasha and learned that he, his mother and sister live a hard life. His father passed away when he was 7, and now his mother is struggling to make ends meet. I assumed correctly that he had never been given the opportunity to go to Israel, so I told him about Taglit-Birthright Israel, the free trip to Israel for 18-26 year olds across the world.

As our evening finished and I got ready to say goodbye to Sasha, I grabbed my wallet, pulled out a twenty shekel bill and handed it to Sasha. I asked that he make a promise to visit Israel and give the twenty shekels to someone in need, thereby performing the *mitzvah* (commandment) of giving *tzedakah*.

That day at the Jewish Agency summer camp outside of Odessa taught me the importance of *klal yisrael* (all of Israel). Sasha lives a hard life without many opportunities to give to those who are less fortunate. Not only did The Federation's annual campaign allow Sasha to attend summer camp, he now knows he is able to experience Israel first hand and can do so with twenty shekels in his pocket to help someone in need. Collectively, we gave Sasha the opportunity to participate in one of the greatest *mitzvot*: the act of giving.






