Charitable IRA Rollover provision is set to expire December 31, 2013

Congress reinstated the IRA Charitable Rollover for 2013 as part of the American Taxpayer Relief Act (ATRA) passed on January 1, 2013. If you are age 70 ½ or older, you may make a gift of up to \$100,000 per year to the Federation from your IRA with no federal income tax impact. Use this opportunity to make your Annual Campaign gift, establish a permanent endowment, or fund a designated program in the Jewish community, such as PJ Library. U7EF does not provide tax or legal advice. Donors should consult with their tax, financial or legal professional as to the best gift method for their situation.

BENEFITS

- Allows donors to make distributions directly from their IRA or Roth IRA to UJEF/ JFGW that avoid federal income tax because the distributions are not included in the donors' federal adjusted gross income.
- Distributions can be used to pay a pledge, establish an endowment or add to an existing endowment. Donors can restrict the purpose of the contributions.
- The distribution counts toward the donor's required minimum distribution.

RESTRICTIONS

- Maximum charitable distribution from the IRA is \$100,000 total in one year.
- Donor must be at least age 70 ½ vears old.
- The provision expires December 31, 2013. Act now!
- Donors do not receive a charitable deduction for the distribution, but the money is not counted in the federal adjusted gross income of the donor.
- Distribution CANNOT be used for a donor advised fund/ philanthropic fund, charitable gift annuity, charitable remainder trust or pooled income fund.

The blue envelope arrives in the mail, addressed to the child and his little sister. It also says, "A gift from The **Iewish Federation of Greater** Washington, the United Jewish Endowment Fund and generous local donors," but he doesn't stop to read that. He rips it open to find this month's PJ Library® book, selected especially for him and runs to his parents shouting, "Read it! Read it!"

These are the moments that happen every month for over 110,000 children across the continent. And now, they will happen all around the Greater Washington area, too. PJ Library sends out high-quality Jewish songs and stories, selected for their timely themes or Jewish values and the child's age level.

Imagine turning the snuggly time with a child or grandchild nestled on your lap into a memorable Jewish moment. UJEF believes in the power of this program to connect Jewish and interfaith families to each other and to Jewish life, making sure that the financial support is there to bring this to 6,000 area families with children under eight years old.

PJ Library also goes beyond the books to engage and welcome families in Jewish activities co-sponsored with JCCs, congregations, preschools and



partner agencies. PJ Library's potential impact appears to be greater for families that are less involved with Jewish community life, including interfaith families. A majority of PI family members report that participating in PJ Library makes them feel more connected to their or their partner's Jewish heritage.

We have enrolled 1,200 families in PJ Library in just the first few weeks since the launch. Clearly, it's a program that has been long desired by area families who had heard about the program's offerings in other communities. We look forward to enrolling families who were not previously connected to Jewish life. In other areas of the country, one-quarter of PJ Library families were previously unknown to the organized Jewish community. Imagine welcoming 1,500 new Jewish families into the community through PJ Library!

In Memory of Dick England (z'l)

At the Create a Fewish Legacy (CFL) training session held in April, Dottie Bennett, Board member and Federation CJL team member, gave a moving D'var Torah. She recalled how Dick England had an impact and will continue to do so through his inspiring actions in our community.

The Torah commands us to perform certain *mitzvot*, among which is the counting of the Omer.

The origins of the Omer count explain that when the Children of Israel left Egypt, they were told by Moses that 49 days after the exodus they would be given the Torah. You can imagine how exciting the prospect of a spiritual liberation would be. Thus, following the physical emancipation from Egypt, they kept count of the passing days that ended with the giving of the Torah at the foot of Mount Sinai.

The Omer may be counted in any language, but understanding what it means is imperative.

There are certain ideas here in these simple sentences that are pertinent to our work:

1) the Torah commands us to do certain things.

2) although you can count in any language, you must understand what you are saying and why you need to act.

Raising money for our Jewish community requires both ideas. You are doing a commandment and you understand the need. Without both of those, neither will be successful.

Memoriam

This brings me to a story I relived this past week as we extolled the amazing leadership our community got from Dick England. I recall, as vividly as if it was yesterday. Dick was standing up at a Federation Board Meeting years ago and saying the following, "I make a big gift to Federation. What would happen if I died today! My gift would be lost and it would take a superhuman effort to make it up, if at all." He proposed endowing his gift so that it would serve the community in perpetuity. He did just that and was the inspiration in my endowing my Lion of Judah and consequently developing other vehicles which are managed by the Endowment Fund.

In his memory, I suggest we all redouble our efforts to count our personal 'Omer' and help insure the future of our Jewish community by speaking the language of Legacy.

Dottie Bennett taught school for more than 20 years and is deeply involved in the issues of Jewish education and in efforts to maintain and enhance Fewish identity. She served on the Board of the United Jewish Endowment Fund, its grants committee and as Vice President for Multiple Appeals of the Jewish Federation of Greater

Stuart Kurlander, president of The Jewish Federation of Greater Washington stated, "Jack was engaging, probing. He asked very often tough questions. He wanted to know and understand. And then there was his soft side."

"Wherever I looked, Iack had been there," said Federation past president Phyllis Margolius, who met Kay when she took a leadership role in the Federation in the early 1980s. "Eventually I became president, Jack had been president. Eventually I chaired the Endowment Fund, Jack had chaired the Endowment Fund. There was hardly a major community campaign that he wasn't part of the

leadership." "He was generous and warm and cared deeply not just about the Jewish community but individual Jews in the community," she continued. "He did things quietly when he could, and publicly when he could be a role model. I can't think of anyone who didn't like Jack. People wanted to be part of what Jack was part of. If Jack was part of your organization, you knew people

would be attracted to you."

Most recently, Joshua Bernstein, CEO of Bernstein Management Corporation and vice president at large for the Federation, was quietly raising funds to allow the Federation to acquire a new building. Kay donated one and a half million dollars. "I said, 'Why are you making things so easy for me?" " Bernstein repeated while laughing at the memory. "He said, 'Why wouldn't I make things easy for you? You're doing great things for the community."

"He wanted to support the next generation of leaders," said Bernstein. "His shoes will not easily be filled."

Jack Kay's final days were spent

in the care of ISSA's hospice, a reminder of the cyclical nature of community - that those who support the community will at some moment in life find themselves recipients of support from the community. "I'm looking at a picture of him and his wife in my office," said ISSA CEO Ken Kozloff, who considered Kay a mentor. "Just such a great guy. Such a wonderful, wonderful guy."

Acorn Fund at a Glance

Acorn Funds give you a way to build an endowment fund over time. When you seed an Acorn Fund, over time, the investment will help the Acorn grow into a much larger endowment fund.

• You contribute at least \$10,000 total into your fund over four years.

- The United Jewish Endowment Fund invests your contribution and waits to make distributions until the fund reaches the target dollar amount or a maximum number of years (up to 30 years).
- Once the target amount or date is reached, your fund will begin to make distributions annually to benefit the Jewish community.
